CLINICAL SUPPORT SERVICES FOR UNDERSERVED COMMUNITIES:

DURING 2025, THE ORGANIZATION FACILITATED 11,957 MEDICAL CONSULTATIONS ACROSS 71 SPECIALTIES, PROVIDED BY APPROXIMATELY 250 VOLUNTEER PHYSICIANS, WITH AN AVERAGE RESPONSE TIME OF 16.38 HOURS. PROGRAM DATA INDICATES THAT 81% OF CONSULTATIONS ELIMINATED THE NEED FOR AN EXTERNAL REFERRAL AND 66% PROVIDED KNOWLEDGE APPLICABLE TO FUTURE PATIENT CARE.
